

# Council Meeting Minutes Tuesday, May 20, 2025

Meeting held at Red Clay Consolidated School District, 1502 Spruce Ave, Wilmington, DE 19805 and via Zoom

#### **Public Session**

- Helen Anderson chaired and opened the meeting at 6:00 pm
- Welcome and Housekeeping provided by Helen Anderson
- Council Roll Call provided by Helen Anderson

  - Approval of 4/15/2025 Minutes Motion by AJe English, seconded by Dr. Lisa Lawson. Vote unanimous. Minutes approved.
  - AJe English read statement for Public Comment guidelines

- Antoinette Curry, Cofounder of MASK(Mothers Advocating for School Kids) –
  Ms. Curry spoke briefly on authentic parent leadership. Families are often
  invited to participate, but only as spectators not to lead. Parents need a seat
  at the table to help make decisions for their children. Ms. Curry looks forward
  to true partnership and collaboration with the WLC.
- Celita Cherry, Cofounder of MASK(Mothers Advocating for School Kids) Ms. Cherry spoke on how parent leadership is not optional, it's essential. She
  also spoke about Community Council meetings she has been attending since
  December and her observation of those meetings. She commented that a
  formal letter was submitted to the WLC outlining concerns about
  transparency, accountability and a conflict of interest.
- Alisha Simpkins, Cofounder of Mask (Mother Advocating for School Kids) Ms. Simpkins spoke about parents being in the room, at the table and in the






process of decision making. She stated that parent engagement should be more than just respondents, surveys and listening sessions. Ms. Simpkins said our children deserve clarity and urgency. She wants to stop the gatekeeping of family involvement and start co-creating with the WLC.

# • Partnership Updates:

- o Educator Support Programs
  - Jounce & Transcend Partner Report Dr. Burgos introduced Carly Highsmith, Director of Educator Pathways with the Wilmington Learning Collaborative.
    - 35 Teacher Leadership Design Fellows across 11 schools
    - 9 WLC schools, plue 2 charter partners
    - Engage in weekly 1/1 coaching, modeling/co-teaching
    - Received a series of two hour training sessions in their chosen pathway of either: Math Instruction, Literacy Instruction,
       Classroom Culture and Student Engagement.
    - Attended Ron Clark Academy RCA experience conference in Atlanta, GA
    - Visited 5 public schools in Washington, DC each school showcased innovative practices aligned with the 3 learning pathways
    - TLDF Timeline:
      - September 2024 Coaching
      - November 2024 Teacher Leadership Model Design
      - December 2024 Experiential Learning
      - Spring 2025 Professional Development Leads
    - WLC and Jounce Partnership
      - Improving student outcomes through coaching of teacher leaders
      - Instructional coaching by Jounce was customized to the role and need of individual teacher leaders.
    - WLC and Transcend Partnership
      - Help teacher leaders design, test and refine innovative classroom experiences that meet the real needs of students





- Move schools towards extraordinary learning environments
- Design a two-week student experience test:
  - > Students felt a strong sense of belonging
  - > Academic confidence and performance increased
  - Behavior and engagement improved
  - > Teachers gained clarity, confidence and momentum

# Approval of Children & Families First Contract Extension:

- Alex Najemy made a motion to approve the Children & Families First contract extension, seconded by Dr. Lisa Lawson. Council voted - 5 yes, 1 abstention, 1 recusal, 2 absent. Vote approved.

# • CSD Update on Principal Search:


- Dr. Burgos gave an overview of the Principal Search process:
  - > Search started in November 2024
  - ➤ Hosted a series of community engagement events
  - > 5 month of sourcing candidates, working closely with National Executive Search Firm, Alma Advisory Group in collaboration with Christina School District
  - ➤ Recommendation was made to the Council at the April 18, 2025 meeting, with a 6 to 1 vote, then submitted to the Christina School Board which did not successfully pass
- Dr. Joyner discussed next steps regarding CSD Principals:
  - ➤ The CSD team will work closely with Dr. Burgos to reset and identify leaders for The Bayard School and Maurice Pritchett Sr. Academy by July 1, 2025

# Approval of FY26 WLC Budget Proposal:

- Proposed FY26 Programmatic Budget Narrative
  - Year 4 July 1, 2025 through June 30, 2026
  - > Total FY26 Allocation \$18,402,513
  - > Carryover \$8,402,513
  - > Year 4 Allocation \$10,000,000





- Proposed FY26 Operational Budget Narrative
  - > Year 4 Funding Breakdown July 1, 2025 through June 30, 2026
  - > Salaries and OECs for WLC Team \$1,138,178
  - > Travel \$175,000
  - Supplies and other Operating Cost \$193,600
  - ➤ Educator Supports \$1,200,000
  - Contractual and Professional Services \$2,604,325
  - Capital Project and Investments \$2,225,000
  - Operational Budget Total \$7,536,103
- Following Council approval, the WLC FY26 Budget Narratives will need to to be reviewed and approved by the Department of Education, Office of Management and Budget, and the Joint Finance Committee.
- Dr. Lisa Lawson made a motion to approve the FY26 WLC Budget
   Proposal, seconded by AJe English. Vote unanimous. Vote approved.
